<b>(15) Special fee for security of passenger aircrafts</b>	
Percentage on the landing fees This fee will be imposed under the circumstances where the following are asked: (a) Luggage control (b) Additional security control of hand luggage and/or passengers (c) Security control of items/cargo/person near or in the aircraft (d) Security control of items/cargo in the airport premises with or without x-rays	15%
<b>(16) Special fees for police guarding of aircrafts</b>	
For every policeman guard for the time period of one hour or part of it	23.41
<b>(17) Special fees for fire brigade services</b>	
For every fire engine for every hour or part of it	52.44

Notes

1. The indexation of Additional Regulated Airport Charges is applicable every 1<sup>st</sup> of May every year. The Additional Regulated Airport Charges are CUTE Fee, BRS Fee, Fire Service Recovery Fee, Security Fee, Fuel Throughput Fee, Air Bridge Rental Charge, Power Supply Fee and Pre-Conditioned Air Fee.
2. The indexation of Existing Regulated Airport Charges is applicable every 1<sup>st</sup> of May every two years. The Existing Regulated Airport Charges include the remaining major charges such as Passenger Fees and Landing Fees.
3. Hermes Airports reserves the right to request the Minister of Communications and Works or to initiate Court proceedings to issue an Order for the grounding of any aircraft with overdue Airport Charges, as provided by the Civil Aviation Law 213(I)/2002 of the Republic of Cyprus.
