AMENDMENTS

Amendments from previous list of charges that was applicable from 1st June 2018 to 30th April 2019, relate to:

- a) The indexation of the Additional and Existing Regulated Airport Charges (Circular FA 45).
- b) The increase of PRM fee from €0.30 to €0.32 per arriving and departing passenger and the increase of Security fee from €2.82 to €3.08 per departing passenger (circular FA46).

Notes

1. The indexation of Additional Regulated Airport Charges is applicable every 1st of May every year. The Additional Regulated Airport Charges are Cute Fee, BRS Fee, Fire Service Recovery Fee, Security Fee, Fuel Throughput Fee, Air Bridge Rental Charge, Power Supply Fee and Pre-Conditioned Air Fee.
2. The indexation of Existing Regulated Airport Charges is applicable every 1st of May every two years. The Existing Regulated Airport Charges include the remaining major charges such as Passenger Fees and Landing Fees.
3. Hermes Airports reserves the right to request the Minister of Communications and Works or to initiate Court proceedings to issue an Order for the grounding of any aircraft with overdue Airport Charges, as provided by the Civil Aviation Law 213(I)/2002 of the Republic of Cyprus.
